
**GARLAND INDUSTRIES, INC. ASSIGNMENT**



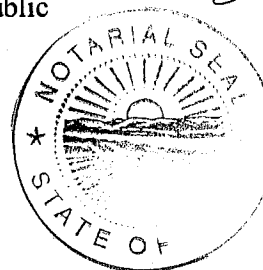
