Degussa AG also hereby assigns, sells, transfers and sets over unto Agomet Klebstoffe Gesellschaft mit beschränkter Haftung all claims for damages for reason of past infringement of said mark, as well as the right to sue for and collect the same for their own use and enjoyment.

Degussa AG further authorizes the Commissioner of Patents and Trademark of the United States to record said mark and registration and title thereto as the property of Agomet Klebstoffe Gesellschaft mit beschränkter Haftung, their successors, legal representatives and assigns in accordance with the terms of this instrument.
