**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Release of Intellectual Property Security Agreement is made this 12<sup>th</sup> day of OCT, 2005 by Caydal, LLC, Jim McCaughey, Michael Alfano, Martin Christen, Mark A. Loewenstein, Kangping K. Loewenstein, Jim Rauh, Dave Gertz Sep IRA, and Ardell Schelich (collectively, the "Secured Parties") to and in favor of HyperSpace Communications, Inc., a Colorado corporation having a mailing address at 8375 S. Willow Street, Suite 400, Littleton, Colorado 80124 ("Debtor").

WHEREAS, the Secured Parties agreed to extend certain financial accommodations to Debtor under that certain Note and Warrant Purchase Agreement dated June 7, 2002, as amended by that certain First Amendment to the Note and Warrant Purchase Agreement dated September 23, 2002, (collectively, the "Purchase Agreement") on condition that the Debtor pledge and grant to Secured Parties as collateral for the obligations of the Debtor to Secured Parties, a security interest and lien in and to the intellectual property collateral and applications therefor, including the registrations thereof, the goodwill associated therewith and all other related claims and rights, as more fully described in a certain Note and Warrant Purchase Agreement ("Intellectual Property");

WHEREAS, Secured Parties recorded the Notice with the U.S. Patent & Trademark Office against the patents listed on Schedule A hereto on September 5, 2003, Reel 013943, Frame 0992 and against the trademarks listed on Schedule B hereto on September 5, 2003, Reel 2710, Frame 0940;

WHEREAS, the indebtedness owing under and in connection with the Purchase Agreement has been fully satisfied and discharged, and Secured Parties desire to release and discharge their security interest in the Intellectual Property;

WHEREAS, Debtor wishes to record this Release of Intellectual Property Security Agreement with the U.S. Patent and Trademark Office; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Secured Parties hereby release and remit to Debtor any and all of Secured Parties' right, title and interest in and to the Intellectual Property, including without limitation the Intellectual Property listed on Schedules A and B hereto.






