**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 13, 2005, by DYMAS FUNDING COMPANY, LLC, as Administrative Agent (“Administrative Agent”).

WITNESSETH:

WHEREAS, Administrative Agent and EMESS Design Group LLC, an Illinois limited liability company (“EMESS”), were parties to that certain Security Agreement (Intellectual Property) Trademarks dated as of June 24, 2004 (the “**Security Agreement**”), pursuant to which EMESS granted a security interest to Administrative Agent in the trademarks and trademark applications set forth on Exhibit A hereto (collectively, the “**Trademarks**”); and

2. Administrative Agent hereby reassigns, grants and conveys to EMESS, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademarks.
