Pursuant to the provisions of the District of Columbia Non-Profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: Cellular Telecommunications Industry Association.

SECOND: The following amendment of the Articles of Incorporation was adopted by the corporation in the manner prescribed by the District of Columbia Non-Profit Corporation Act:

Amend Article FIRST to read as follows:

"The name of the corporation is Cellular Telecommunications &
Internet Association."

THIRD: The amendment was adopted at a meeting of members held on November 27, 2000, at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.


