TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 13, 2005, by DYMAS FUNDING COMPANY, LLC, as Administrative Agent (“Administrative Agent”).

WITNESSETH:

2. Administrative Agent hereby reassigns, grants and conveys to Stein World, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademarks.
