TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 13, 2005, by DYMAS FUNDING COMPANY, LLC, as Administrative Agent (“Administrative Agent”).
