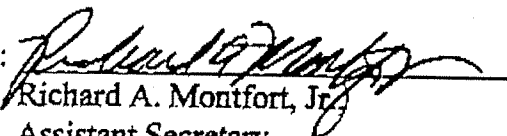
Article First of the Certificate of Incorporation is amended to read as follows:
