NOW THEREFORE, for valuable consideration, receipt of which is hereby acknowledged:

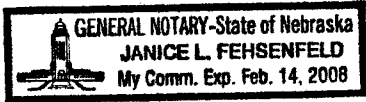

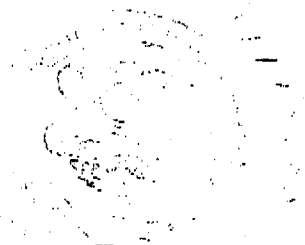
