TRADEMARK ASSIGNMENT

THIS AGREEMENT is dated as of April 29, 2005.

WHEREAS, Cambridge Eye Associates, Inc., a Delaware corporation, Douglas Vision World, Inc., a Delaware corporation, and Sight Resource Corporation, a Delaware corporation (collectively, "Assignors"), have adopted, acquired, used and are using exclusively in their business the trademarks listed on Exhibit A attached hereto and made a part hereof (the "Trademarks"); and

WHEREAS, Empire Vision Center, Inc., a New York corporation ("Assignee"), is desirous of acquiring all right, title and interest in and to said Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns, all of its right, title and interest, whether statutory or at common law, in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks in the United States and all countries throughout the world, and together with the right to sue and collect damages and/or profits for past infringements of the Trademarks, the intent hereof being to substitute Assignee in the place of Assignor.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States or any State whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Agreement.

Assignor further agrees to execute such further documents as may be required to record Assignee as the owner of the Trademarks and registrations and applications herein assigned.

This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.
