KNOW ALL MEN BY THESE PRESENTS that The Peninsula Fund II Limited Partnership (the "Funds"), a Delaware limited partnership, as collateral agent for and on behalf of the Funds, (in such capacity, "Collateral Agent") for One Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby release and discharge the security interests in the trademarks shown in Schedule A attached hereto, and incorporated in this Release by reference, granted to it by Cloud Packaging Services LLC (the "Security Interests").
