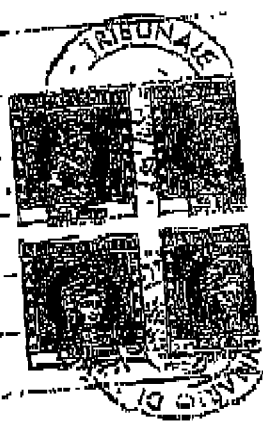

As a result, the inheritors of the estate include: 1) Olga TSARPELA, his widow; 2) Alessandro BOSCO, his minor child in custody of Olga TSARPELA; 3) Carla Marta Stefania BOSCO, his daughter; and 4) Manuela Anna Maria BOSCO, his other daughter. According to the Italian Civil Code, an extract of which was included with the filing, Mr. BOSCO's wife is entitled to 1/3 of the inheritance, whereas his son and daughters are entitled to 2/3 of the inheritance as a whole. This means that Mrs. TSARPELA inherited 1/3 of the patent application, whereas his son and daughters inherited 2/9 of the patent application each. Also enclosed was a copy of Carmelo BOSCO's Death Certificate, with relevant English translation.

Applicant believes that the paperwork as originally filed reflects the legal transfer of Applicant's rights of the application to his heirs and provides supporting documentation as proof thereof.

Since Applicant has responded within 30 days from the date of the Notice, Applicant requests that the assignment's original filing date be maintained. Furthermore, since Applicant responded in a timely fashion, no additional fees should be required. However, if deemed
