**CERTIFICATE OF AMENDMENT
OF
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
SORRENT, INC.**

The undersigned, L. Gregory Ballard and Paul Zuzelo, hereby certify as follows:

1. They are respectively the President and Secretary of Sorrent, Inc., a California corporation (this "Corporation").

2. Article 1 of the Amended and Restated Articles of Incorporation of this Corporation is hereby amended to read in its entirety as follows:

"The name of this Corporation is Glu Mobile Inc."

3. The foregoing amendment of Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of this Corporation.

4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Sections 902 and 903 of the California Corporations Code. The corporation has two classes of stock, Common Stock and Preferred Stock. The number of outstanding shares of the Corporation is 14,872,193 shares of Common Stock and 34,224,375 shares of Preferred Stock, consisting of 6,940,096 shares of Series A Preferred Stock, 8,593,750 shares of Series B Preferred Stock, 12,046,016 shares of Series C Preferred Stock and 6,644,513 shares of Series D Preferred Stock. The number of shares voting in favor of the foregoing amendment of the Amended and Restated Articles of Incorporation equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding shares of Preferred Stock (on an as-converted to Common Stock basis), voting together as a single class, and more than 50% of the outstanding shares of Common Stock and Preferred Stock (on an as-converted to Common Stock basis), voting together as a single class.
