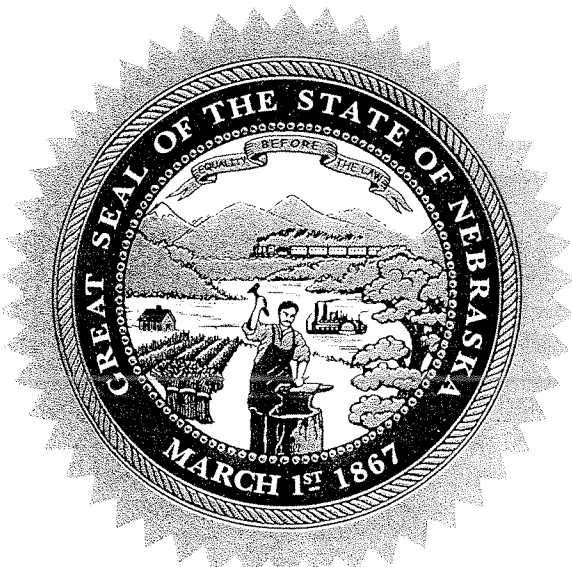

AMENDMENT AND RESTATEMENT
OF
THE ARTICLES OF INCORPORATION
OF
ISCO, INC.

Pursuant to the provisions of Neb. Rev. Stat. Section 21-20,122, the undersigned corporation hereby amends and restates the Articles of Incorporation of Isco, Inc.

1. The name of the corporation is Isco, Inc., to hereafter be known as Teledyne Isco, Inc.
2. The Amended and Restated Articles of Incorporation of the corporation are attached hereto as Exhibit A.
3. The restatement contains an amendment to the Articles of Incorporation of the corporation which required shareholder approval.
4. The number of shares of the corporation which were outstanding at the time of approval of the Amended and Restated Articles of Incorporation by the shareholders was 1,000 shares of common stock. The Amended and Restated Articles of Incorporation were adopted by unanimous written consent of the sole shareholder of the corporation, which was sufficient for approval.
5. The Amended and Restated Articles of Incorporation supercede the original Articles of Incorporation of the corporation and all amendments thereto.

AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
TELEDYNE ISCO, INC.
(formerly known as Isco, Inc.)

These Amended and Restated Articles of Incorporation amend and restate in their entirety the Articles of Incorporation of Isco, Inc.

ARTICLE I

NAME

The name of the corporation is hereby changed from Isco, Inc. to **Teledyne Isco, Inc.**

ARTICLE II

DURATION

The period of the corporation's duration is perpetual.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is to transact any or all lawful business for which the corporation may be incorporated under the Nebraska Business Corporation Act.

ARTICLE IV

AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have the authority to issue is One Thousand (1,000) shares of common stock and the par value of each of said shares shall be \$0.10.

ARTICLE V

INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT



ARTICLE VI

LIMITATION OF DIRECTOR LIABILITY

No director shall be liable to the corporation or its shareholders for monetary damages for any action taken, or any failure to take any action, as a director, provided, however, that this provision shall not eliminate or limit the liability of a director for (i) the amount of a financial benefit received by the director to which he or she is not entitled; (ii) an intentional infliction of harm on the corporation or its shareholders; (iii) the violation of Section 21-2096 of the Nebraska Business Corporation Act; or (iv) an intentional violation of criminal law.

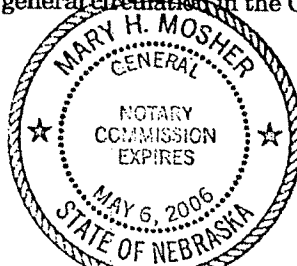
