RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Trademark Security Interest Release is granted and conveyed as of October 13, 2005, by ICG Holdings, Inc., a Delaware corporation, having an office at Pencader Corporate Center, 100 Lake Drive, Suite 4, Newark, Delaware 19702 (hereinafter referred to as "ICG Holdings"), in favor of CommerceQuest, Inc., a Florida corporation, having an office at 5481 West Waters Avenue, Suite 100, Tampa, FL 33634-1205 (hereinafter referred to as "CQ").

WHEREAS, the records of the United States Patent and Trademark Office ("PTO") reflect that ICG Holdings and Internet Capital Group, Inc., a Delaware corporation, entered into an Assignment and Acceptance (the "Assignment"), dated as of September 30, 2004, pursuant to which ICG Holdings purchased from ICG certain convertible promissory notes secured by an interest in the CQ trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, the PTO recorded the Assignment on October 20, 2005, at Trademark Reel 3179 Frame 127;

WHEREAS, CQ has satisfied all of its outstanding obligations and the parties seek to make a record of ICG Holding's release to CQ of its security interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, ICG Holdings hereby (1) releases, discharges, and relinquishes, as of October 13, 2005, its security interest in the Marks. ICG Holdings specifically acknowledges that the security interest is no longer effective, and that ICG Holdings does not own any rights to or have any ownership interest in the Marks.
