THIS AGREEMENT is made on 10 April 1997.

BETWEEN:

- (1) **KANGOL LIMITED** a company incorporated in England and Wales (registered no. 0335512) whose registered office is at Cleator Mills, Cleator, Cumbria CA23 3DJ ("Kangol");
- (2) **THE MARMON GROUP LIMITED** a company incorporated in England and Wales (registered no. 1376182) whose registered office is at Broadacre House 16-20 Lowther Street, Carlisle, Cumbria CA3 8DA ("TMG").

WHEREAS:

- (A) On 9 April 1997 Kangol declared an interim dividend of £7,735,000 in specie by means of the transfer by Kangol to TMG. Kangol's sole shareholder, of the Kangol and associated trade marks registered (and applied for) in Kangol's name everywhere in the world, save for those registrations and applications in the Czech Republic, Georgia, Indonesia, Oman, Panama, Poland and the Philippines where the transfer of trade marks without the assets of the associated business would be invalid (the "Dividend"); and
- (B) The Dividend is to be partially satisfied by the transfer to TMG of the trade mark registrations, registered designs and applications for registration, particulars of which are set out in the annexure to this Agreement, (the "Kangol Primary Non-UK Trade Marks") on the terms of this Agreement.

IT IS AGREED as follows:

1. Kangol hereby transfers and assigns to TMG with full title guarantee free from encumbrances other than permitted encumbrances agreed between them all the Kangol Primary Non-UK Trade Marks, in each case together with the right to sue for damages and all other remedies in respect of any infringement thereof or any passing off in relation to the above which may have occurred prior to the date hereof to hold the same unto TMG, its successors and assigns absolutely for the whole duration of the same together with any renewals, revisions and extensions.
2. Kangol agrees that it shall execute any further documents, forms and authorisations, swear any declaration or oath and do such other acts and things, including those required by any

registrar of trade marks for vesting absolutely the full title and interest in and to the Kangol Primary Non-UK Trade Marks pursuant to the provisions of this Agreement.

3. The parties acknowledge between them that the transfer of the Kangol Primary Non-UK Trade Marks operates as a voluntary disposition inter vivos for no consideration in money or money's worth nor any consideration referred to in section 57 of the Stamp Act 1891.
4. This Agreement shall be governed by English law.
5. This Agreement may be executed in any number of counterparts each of which when executed and delivered is an original, but all the counterparts together constitute the same document.
