RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of October 25, 2005, made by LaSalle Bank National Association, a national banking association ("Lender") in favor of Milk Specialties Company, a Delaware corporation.

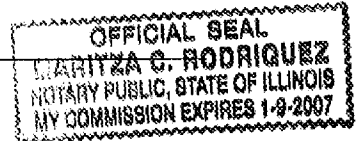
