RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL ("Release") is made as of October 21, 2005, by Union Bank of California, N.A., a national banking association ("Bank") the secured party under that certain Intellectual Property Security Agreement referred to below.

WHEREAS, P-COM INC. (Pledgor), executed that certain Intellectual Property Security Agreement dated as of May 15, 1998, (the "Security Agreement"), pursuant to which Pledgor granted to Bank a security interest in certain Trademarks owned and registered by Pledgor; and

WHEREAS, the Security Agreement was recorded with the United States Department of Commerce Patent and Trademark Office on May 29, 1998 at Reel 1739, Frame 0329; and

WHEREAS, Bank has agreed to release all of its rights under the Security Agreement, including without limitation all of its rights in and to the Trademark identified on Exhibit A attached hereto and made a part hereof (the "Released Trademarks"), and to reconvey to Pledgor all of its rights in and to the released Trademarks;

NOW, THEREFORE, in consideration of the premises hereof, and other good and valuable consideration the receipt of which is hereby acknowledged, Bank hereby releases all of its rights in and to the Released Trademarks, reconveys to Pledgor all of its right, title and interest in and to the Released Trademarks, releases all other rights it may have under the Security Agreement with respect to the Released Trademarks, and cancels the Security Agreement in its entirety.

Bank hereby represents and warrants that it has not heretofore transferred to any other person or entity any of the rights in and to the Released Trademarks that were granted to it pursuant to the Security Agreement.

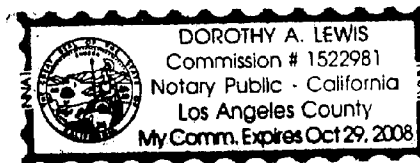
