TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made this 21st day of March, 2003, between JPMORGAN CHASE BANK (formerly known as The Chase Manhattan Bank) ("Assignor") and UNITED STATIONERS SUPPLY CO., an Illinois corporation ("Assignee").

WHEREAS, Assignee had adopted and used in the United States the trademarks, and owned the registrations and applications thereof, and later assigned to Assignor the trademarks as listed in Schedule A attached hereto (the "Marks") in connection with that certain Third Amended and Restated Credit Agreement dated as of June 29, 2000 between Assignee, United Stationers, Inc., the several lenders party thereto (the "Lenders") and the Assignor, as administrative agent for the Lenders (the "Credit Agreement"; capitalized terms used but not otherwise defined herein having the meaning ascribed to them in the Credit Agreement); and

WHEREAS, in connection with the satisfaction and payment in full of all of Assignee's obligations arising pursuant to the Credit Agreement and Security Documents, Assignee has requested, and Assignor, on behalf of the Lenders, has agreed, to assign to Assignee all of Assignor's right, title and interest in and to the Marks, and the registrations and applications thereof, and the goodwill associated therewith, and to terminate and release all liens and security interests in the Marks which were granted to Assignor in connection with the Credit Agreement and Security Documents;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys unto Assignee, its successors and assigns, as successor to Assignor's business, all of its rights, title and interest in and to the Marks, whether statutory or at common law, including all registrations and applications thereof, together with the existing and ongoing business to which the Marks pertain as well as the goodwill of the business symbolized by the Marks, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof.

ASSIGNOR, at the expense of the Assignee, agrees to execute any further papers and to do such other acts as may be necessary and proper to vest full title in and to the Marks and the good will of the business symbolized by the Marks, and the registrations and applications thereof.

The Commissioner of Patents and Trademarks of the United States is requested to issue the Certificates of Registration for the pending Marks to the Assignee upon registration.
