ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY ("Assignment") effective as of the 27th day of April, 2005 (the "Effective Date") by Starad, Inc., a New York corporation having offices at 500 Saw Mill River Road, Elmsford, NY 10523 ("Assignor") to Rauch Industries, Inc., a North Carolina corporation having offices at 2408 Forbes Road, Gastonia, North Carolina 28056 ("Assignee").

WHEREAS, Assignor is a subsidiary of Assignee and Assignee has agreed to accept and assume from Assignor all right, title and interest in and to certain trademarks and trademark applications (collectively the "Marks") and copyrights of Assignor (the "Copyrights") (the Marks and Copyrights are identified on Exhibit A hereto and hereafter referred to collectively as the "Rights"). Both parties desire such assignment in connection with the acquisition of Assignor by Assignee and further in order to facilitate the reorganization of Assignor and Assignee and to enable Assignee to pursue additional financing to increase the working capital of Assignor and Assignee to further commercialize the Rights.

NOW, THEREFORE, in consideration of: the payment of debts of Assignor by Assignee to both secured and unsecured creditors, facilitating the reorganization of Assignor and Assignee, enabling Assignee to obtain additional financing to be used to increase the working capital of Assignor and Assignee, obtaining additional capital to commercialize the products of Assignor and Assignee, the license granted herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby assigns, transfers and conveys to Assignee, and Assignee accepts, all of Assignor's right, title and interest throughout the world in and to the Rights, including but not limited to all of the goodwill symbolized by and related to the Marks and all causes of action, claims, demands presently or hereafter accruing with respect to the Rights, including the right to sue or bring other actions for past, present and future infringement thereof anywhere in the world.

2. Protection. Assignor further assigns all rights to, and empowers Assignee, its successors, assigns and nominees to, make applications for trademark, copyright or other intellectual property registration or protection related to the Rights anywhere in the world, to claim and receive the benefit of any applicable rights of priority in connection with such applications, to prosecute such applications to issue, and to have any and all registrations issued in the name of Assignee.

3. Further Assurances. Assignor further agrees that Assignor will: (i) cooperate with Assignee in the filing and prosecution of any and all trademark, copyright or other intellectual property registrations or applications; (ii) execute, verify, acknowledge and deliver all such further papers, including applications and instruments of transfer; and (iii) perform such other acts as Assignee lawfully may request, to facilitate Assignee's right to obtain, protect, maintain, defend or enforce any of the Rights granted hereunder. In the event that Assignee is unable for any reason whatsoever to secure Assignor's signature to any document when so required to effectuate fully this Assignment, Assignor hereby irrevocably designates and appoints Assignee

and Assignee's duly authorized officers and agents, as Assignor's agents and attorneys-in-fact to act for and on its behalf and instead of it, to execute and file any such document and to do all other lawfully permitted acts to further the purposes of the foregoing, with the same legal force and effect as if executed by Assignor.

4. License Grant. Assignee hereby grants to Assignor a non-exclusive, royalty-free, perpetual, worldwide license to (i) use, display, and reproduce the Marks and market, sell, and distribute products and services under the Marks and (ii) modify, copy, perform, display, distribute, and prepare derivative works of the Copyrights (collectively the rights granted in (i) and (ii) the "License"). The License is sublicensable but is not otherwise transferable and Assignor shall be liable to Assignee for Assignor's sublicensees adherence to the provisions of Sections 4, 5, and 6 of this Agreement. The License will remain in effect unless and until terminated in accordance with the following. If Assignor should violate the terms of the License, Assignee may terminate the License upon ten (10) days written notice unless the breach is cured within such ten (10) day notice period. The remaining provisions of this Agreement shall survive termination of the License.

5. Scope of License. Assignor hereby acknowledges and agrees that, except for the license rights set forth herein, Assignor has no right, title or interest in or to the Marks or Copyrights and that all use of the Marks by Assignor and any goodwill associated therewith shall inure to the benefit of Assignee. Assignor understands and agrees that it does not have the right to use the Marks or Copyrights in any manner that conflicts with the rights of any third party. If, in Assignee's sole determination, Assignor's use of the Marks or Copyrights infringes the rights of any third party or weakens or impairs Assignee's rights in the Marks or Copyrights, then Assignor agrees to immediately terminate or modify such use in accordance with Assignee's instructions. Assignor may not alter or deface the Marks.

6. Quality Control. Upon Assignee's request, Assignor shall furnish to Assignee, at no expense to Assignee, samples of all materials containing the Marks that Assignor currently distributes or intends to distribute. Assignee shall control the quality of all materials bearing the Marks and all use by Assignor of the Marks. If Assignee believes that the Marks are being used in a manner that could diminish Assignee's rights in or protection of the Marks, Assignor agrees, at Assignor's sole cost and expense, to make whatever changes and/or corrections Assignee deems necessary to protect the Marks. Assignor agrees that it shall not engage, participate or otherwise become involved in any activity or course of action that diminishes and/or tarnishes the image and/or reputation of the Marks.

7. Warranty. Assignor represents and warrants that Assignor has all rights necessary to make the assignment herein.

8. General. The failure of a party to require performance by another party of any provision hereof shall not affect the full right to require such performance at any time thereafter; nor shall the waiver by either party of a breach of any provision hereof be taken or held to be a waiver of the provision itself. If any provision of this Agreement is held to be illegal or unenforceable, such provision shall be limited or eliminated to the minimum extent necessary so that the remainder of this Agreement will continue in full force and effect and enforceable. This Agreement shall be interpreted and controlled by and construed and enforced according to the

laws of the State of Delaware without regard to conflicts of laws provisions thereof. The parties specifically submit themselves to the jurisdiction of the state and federal courts sitting in Delaware. Both parties agree that process may be served in the manner provided herein for giving of notices or otherwise as allowed by Delaware or U.S. federal law. This Agreement shall not be modified except by a subsequently dated written amendment signed by a duly authorized representative of each party. This Agreement may be executed in multiple counterparts, each of which will be considered an original, but all of which together will constitute one and the same instrument.

IN WITNESS, WHEREOF, the undersigned has caused this Assignment to be executed by the signature of its duly authorized officer as of the date above first written.
