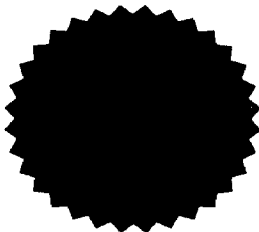

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, in accordance with Section 141(f) of the DGCL, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the current text of "ARTICLE ONE" of the Corporation's Restated Certificate of Incorporation is deleted in its entirety and replaced with the following:

The name of the Corporation is Apogen Technologies, Inc.
