## TRADEMARK AND DOMAIN NAME ASSIGNMENT

Assignor further agrees to execute and deliver to Assignee such further assignments and related documents, with respect to the Transferred Intellectual Property and Intellectual Property Rights, as Assignee shall reasonably request (all at Assignee's expense).

This Trademark and Domain Name Assignment is binding upon the parties and their respective successors and assignees.

Notwithstanding any other provisions of this Trademark and Domain Name Assignment to the contrary, nothing contained herein shall in any way supersede, modify, replace, amend, change, rescind, expand, exceed or enlarge or in any way affect the provisions, including the representations, warranties, covenants, agreements, conditions, or in general, any rights and remedies, and any of the obligations set forth in the Agreement. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

This Assignment may be signed in one or more counterparts, each of which shall be an original and all of which shall be considered one and the same assignment.




