**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
NATIONAL DIALOGUE ON CANCER**

Pursuant to the provisions of the District of Columbia Nonprofit Corporation Act, National Dialogue on Cancer adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is National Dialogue on Cancer (the "Corporation").

SECOND: The following amendments to the Corporation's Articles of Incorporation were adopted by the Corporation in the manner prescribed by the District of Columbia Nonprofit Corporation Act:

A. The heading of the Articles of Incorporation is hereby amended to read in its entirety: "ARTICLES OF INCORPORATION OF C-CHANGE"

B. Article One of the Articles of Incorporation is hereby amended in full to read as follows:

ARTICLE ONE

The name of the corporation is C-Change (the "Corporation").

THIRD: This amendment was adopted at a meeting of the members held on November 20, 2004, at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.
