RELEASE OF SECURITY INTEREST

AGREEMENT made as of this 24th day of June, 2005, by and between LaSalle Bank National Association, with its main office at 135 South LaSalle Street, Chicago, Illinois 60603, (the "Lender"), and Pabst Brewing Company, a Delaware corporation, with its principal place of business at 100 Shoreline Highway, Bldg. B - Suite 395, Mill Valley, California 94941 (the "Borrower").

WITNESSETH:

WHEREAS, pursuant to a Security Agreement dated as of October 11, 2002, between Lender and Borrower (the "Security Agreement"), Borrower pledged and mortgaged to Lender certain trademarks, including, without limitation, the trademark listed on the attached Schedule A (the "Trademark"); and

WHEREAS, Lender has agreed to release its pledge and mortgage in the Trademark and reassign its interest therein to Borrower;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Lender and Borrower hereby agree as follows:

1. Lender hereby releases its mortgage, pledge and security interest in the Trademark.
2. Lender hereby assigns and transfers to Borrower its entire right, title and interest in and to the Trademark and any United States trademark application or registration reflecting the Trademark, together with all of the Lender's right, title and interest in any cause of action that has heretofore arisen or may hereafter arise, with respect to the Trademark, the same to be held and enjoyed by the Borrower for its own use and benefit and the use and benefit of its legal representatives successors and assigns.
3. The date of this Agreement first set forth above is for identification purposes only and is the date this Agreement is deemed to have been delivered by the Lender to the Borrower. This Agreement was executed by the parties on the date set forth in the acknowledgements below.

IN WITNESS WHEREOF, Borrower and Lender have caused this Agreement to be executed by their duly authorized officers, all as of the day and year first above written.

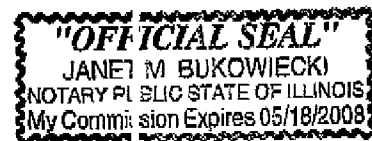
