1. They are, respectively, the President and the Secretary of IRORI DISCOVERY, INC., a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of this corporation is amended in its entirety to read as follows:

I


The name of this corporation is NEXUS BIOSYSTEMS, INC.

3. The foregoing amendment of the Amended and Restated Articles of Incorporation of this corporation has been duly approved by the board of directors.

4. The foregoing amendment of the Amended and Restated Articles of Incorporation of this corporation has been duly approved by the required vote of shareholders in accordance with Section 902 and Section 903 of the California Corporations Code. The total number of outstanding shares of this corporation's Common Stock is Two Million Four Hundred Thousand (2,400,000). The total number of outstanding shares of this corporation's Series A Preferred Stock is Three Million (3,000,000). The number of shares of this corporation's Common Stock voting in favor of the amendment equaled or exceeded the vote required, and the percentage vote required was more than fifty percent (50%). The number of shares of this corporation's Series A Preferred Stock voting in favor of the amendment equaled or exceed the vote required, and the percentage vote required was at least sixty six and two thirds percent (66 & 2/3%).
