ASSIGNMENT

THIS ASSIGNMENT, made effective as of the 30th day of September, 2005, by T.J. WHEREAS, Assignor wishes to assign such Assigned Intellectual Property to Assignee and Assignee wishes to accept the assignment of such Assigned Intellectual Property;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that for and in consideration of payment by Assignee to Assignor of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor by these presents hereby assigns and transfers to Assignee, and any successors, assigns, nominees and/or legal representatives of Assignee, the entire right, title and interest of Assignor in and to said Assigned Intellectual Property.


