## TRADEMARK ASSIGNMENT




This Assignment includes all rights in the nature of the trademark, service mark, and trade name rights, as well as the right to sue for past infringement by any third party.

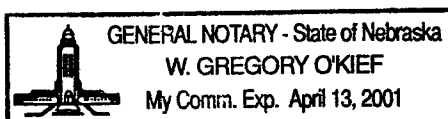
