## ASSIGNMENT AND SECURITY RELEASE AGREEMENT

- (c) all license agreements with any other party which by their terms are assignable, whether ABC is a licensee or licensee under any such agreement described in and/or claimed under the Agreement, including, but not limited to the licenses listed on Schedule B attached hereto; and
- (d) the proceeds and products of any and all of the foregoing.

KCC hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the assignments granted herein and the release of the security interests contemplated hereby. Capitalized terms not defined herein have the mean set forth in the Agreement.
