NUNC PRO TUNC ASSIGNMENT

WHEREAS, The Risk Management Association, a 501(c)(6) not-for-profit corporation organized and existing under the laws of the Commonwealth of Pennsylvania, with a place of business at 1801 Market Street, Suite 300 Philadelphia, Pennsylvania 19103 ("Assignor"), assigns and transfers, effective February 28, 2004, to Wescoco LLC, a Delaware limited liability company, at 5th Floor, 660 Market Street, San Francisco, California 94104 ("Assignee"), the entire right, title and interest in and to the following (collectively, the "Trademark Rights"):

U.S. Trademark Registration No. 1,937,719 for the mark FASTFIND as used in association with "information services, namely offering banking and business lending information and bibliographies"; and

Any renewals therefor, and all of RMA's associated protectable rights whether statutory or common law in the mark FASTFIND, as used in association with "information services, namely, offering banking and business lending information and bibliographies" as well as the GOODWILL of the RMA business with which the mark has been used; together with the right to bring suit and collect for past infringements thereof..


NOW, THEREFORE, in view of the payment of Ten Dollars (\$10.00), and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor DOES HEREBY assign and transfer, nunc pro tunc, as of February 28, 2004, to Assignee, all right, title and interest in and to the Trademark Rights.

Assignor shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in Assignee good, valid and marketable title to the Trademark Rights.

This Assignment and all terms hereof shall be binding upon and shall inure to the benefit of the parties and the respective heirs, personal and legal representatives, successors and assigns.
