ASSIGNORS further assign to ASSIGNEE the right to claim priority or other rights deriving from any trademark application of the TRADEMARKS by virtue of international convention, treaty, or

otherwise. The TRADEMARKS and all trademarks, trademark registrations and trademark applications assigned hereby are to be held and enjoyed by ASSIGNEE for its use and benefit and by its successors and assigns for their use and benefit as fully and entirely as the same would have been held and enjoyed by ASSIGNORS had this agreement, transfer and sale not been made.


