RELEASE OF TRADEMARK SECURITY

This Release of Trademark Security is made as of the 30th day of September, 2005 (the "Payoff Date"), by and between Thermo BioStar Inc. (f/k/a BioStar, Inc.), a Delaware corporation with offices at 6655 Lookout Road, Boulder, CO 80301 ("Debtor") and Thermo BioAnalysis Corporation, a Delaware corporation with an office at 81 Wyman Street, Waltham, MA 02454 ("Secured Party").

WHEREAS, a security interest given by Debtor and Secured Party was recorded on September 4, 1998 by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 1788/0684 (the "First Security Interest").

WHEREAS, a security interest given by Debtor to Secured Party was recorded on January 27, 1999 by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 1844/0596 (the "Second Security Interest" and together with the First Security the "Security Interests").

WHEREAS, a change of name from BioStar, Inc. to Thermo BioStar Inc. was recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 2246/0800.

WHEREAS, the Debtor has repaid the obligations owed to Secured Party under the above recorded Security Interests and Secured Party has agreed to terminate, release and discharge its security interest in all the Trademarks listed on Schedule A.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor and Secured Party hereby agree as follows:

As of the Payoff Date, all of the Security Interests shall be automatically terminated, released and discharged, and the Secured Party hereby authorizes Debtor to file any such documents, including filings with the U.S. Patent and Trademark Office against the trademarks listed in Schedule A hereto, as shall be necessary to effect the termination, release and discharge of all of the Security Interests. In addition, promptly upon the request of Debtor, Secured Party will do any and all other acts and things and execute and deliver any and all other documents or instruments that Debtor may reasonably require and at Debtor's expense.

This Release may be executed in any number of counterparts, but all of such counterparts shall together constitute one and the same instrument. This Release shall be governed and construed in accordance with the laws of The Commonwealth of Massachusetts, without regard to the principles thereof relating to conflict of laws.
