**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
STERILE RECOVERIES, INC.**

Pursuant to Section 607.1006 of the Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I.

The name of the Corporation is **STERILE RECOVERIES, INC.**

ARTICLE II.

The Articles of Incorporation are amended by deleting Article I in its entirety and replacing it with the following:

"ARTICLE I

The name of the Corporation is: **SRI/Surgical Express, Inc."**

This amendment is effective as of January 1, 2001.


