## ASSIGNMENT AND ASSUMPTION AGREEMENT

Reference is made to (i) the Trademark Security Agreement, dated as of September 29, 2004 (the "TSA"), among Spinneybeck Enterprises, Inc. (the "Grantor"), a New York corporation, and UBS AG, Stamford Branch ("UBS") (as administrative agent under that certain Guarantee and Collateral Agreement, dated as of September 30, 2004, among the Grantor, certain affiliates of the Grantor and UBS (the "Guarantee and Collateral Agreement")), filed at the United States Patent & Trademark Office on October 5, 2004 at Reel/Frame Nos. 002951/0492 and covering the intellectual property listed on schedule I attached hereto and (ii) the Master Assignment Agreement, dated as of October 3, 2004 (the "Master Assignment Agreement"), among the Grantor, certain affiliates of the Grantor, UBS and Bank of America, N.A. ("Bank of America") pursuant to which UBS has assigned to Bank of America all of its interests, rights and obligations under the Guarantee and Collateral Agreement and the TSA.

This Assignment and Assumption Agreement is entered into as of October 3, 2005 (the "Effective Date") between UBS and Bank of America.

Pursuant to the Master Assignment Agreement, UBS hereby irrevocably assigns to Bank of America without recourse, and Bank of America hereby irrevocably assumes from UBS, as of the Effective Date, all of UBS's interests, rights and obligations under the TSA.

Following the execution of this Assignment and Assumption Agreement, it will be delivered to Bank of America for recording with the United States Patent and Trademark Office.

This Assignment and Assumption Agreement may be executed in any number of counterparts and by the different parties on separate counterparts and each such counterpart shall be deemed to be an original, but all such counterparts shall together constitute but one and the same agreement. This Assignment and Assumption Agreement shall be governed by and construed in accordance with the laws of the State of New York.




