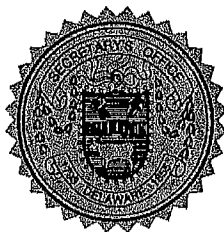

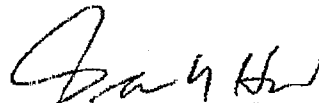
**CERTIFICATE OF AMENDMENT
