AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT

This Amendment to Patent and Trademark Security Agreement (this "Amendment") is made as of June 30, 2005 by and between PAPERPAK PRODUCTS, INC., a Delaware corporation, formerly known as USPP Holdco, Inc. ("Debtor") and WELLS FARGO BUSINESS CREDIT, INC., a Minnesota corporation ("Secured Party") with respect to the following facts:

A. Debtor and Secured Party are parties to that certain Patent and Trademark Security Agreement dated as of September 6, 2002 (the "Agreement"), and recorded with the United States Patent and Trademark Office with respect to the Patents (as defined in the Agreement) on September 18, 2002 at Reel 013280, Frame 0886, and recorded with the United States Patent and Trademark Office with respect to the Trademarks (as defined in the Agreement) on September 10, 2002 at Reel 002583, Frame 0778.

B. Since the date of the Agreement, Debtor has acquired or made Secured Party aware of the existence of the patents and related registrations and applications set forth on Exhibit A hereto (the "New Patents").



C. Since the date of the Agreement, Debtor has acquired or made Secured Party aware of the existence of the trademarks and related registrations and applications set forth on Exhibit B hereto (the "New Trademarks").

D. Debtor and Secured Party now desire to amend the Agreement to cover the New Patents and the New Trademarks.

NOW THEREFORE, the Agreement is hereby amended to (i) add the New Patents to Exhibit A of the Agreement, and the term "Patents" as defined and used in the Agreement shall include the New Patents; and (ii) add the New Trademarks to Exhibit B of the Agreement, and the term "Trademarks" as defined and used in the Agreement shall include the New Trademarks. In all other respects, the Agreement shall remain in full force and effect and is hereby ratified and confirmed.


