## INTELLECTUAL PROPERTY SECURITY AGREEMENT

**THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "IP Security Agreement") is made and entered into as of October 26, 2005, by **CROCS, INC.**, a Delaware corporation, successor by merger to Crocs, Inc., a Colorado corporation (the "Borrower" and the "Grantor") and **BANK OF AMERICA, N.A.**, a national banking association, as Lender (the "Lender").

### WITNESSETH:

**WHEREAS**, the Lender has agreed to provide to the Borrower a revolving credit facility pursuant to the Amended and Restated Credit Agreement dated as of October 26, 2005, by and among the Borrower and the Lender (as from time to time amended, revised, modified, supplemented or amended and restated, the "Credit Agreement"), which Credit Agreement, amends, renews, modifies and extends the Credit Agreement dated as of April 8, 2005 by and among the Borrower and the Lender; and

**WHEREAS**, in connection with the Credit Agreement, Borrower has executed and delivered an Amended and Restated Security Agreement dated as of October 26, 2005, by and among the Borrower and the Lender (as from time to time amended, revised, modified, supplemented or amended and restated, the "Security Agreement"); and

**WHEREAS**, the Lender is unwilling to enter into the Loan Documents unless the Borrower enters into this IP Security Agreement;

**NOW, THEREFORE**, in order to induce the Lender to enter into the Loan Documents and to make Loan, and in further consideration of the premises and the mutual covenants contained herein, the parties hereto agree as follows:

1. **Certain Definitions.** All capitalized terms used but not otherwise defined herein, and not otherwise expressly defined in the Credit Agreement or the Security Agreement, and for which meanings are provided in the Uniform Commercial Code of the State of North Carolina (the "UCC"), shall have such meanings.

2. **Grant of Security Interest.** The Borrower hereby grants as collateral security for the payment, performance and satisfaction of all of the Borrower's Obligations, and the prompt payment and performance when due of its obligations and liabilities hereunder and under all other Loan Documents to which it is a party (collectively, the "Secured Obligations"), to the Lender a continuing first priority security interest in and to, and collaterally assigns to the Lender all of the following property of the Grantor or in which the Grantor has or may have or acquire an ownership interest or the power to transfer rights therein, whether now owned or existing or hereafter created, acquired or arising and wheresoever located:

(a) All copyrights (whether statutory or common law, registered or unregistered), works protectable by copyright, copyright registrations, copyright licenses (to the extent such licenses permit Borrower to grant a security interest), and copyright applications of Borrower, including, without limitation, all of Borrower's right, title, and interest in and to all copyrights registered in the United States Copyright Office or anywhere else in the world and also including, without limitation, the copyrights set forth on Schedule A; (ii) all renewals, extensions, and modifications thereof; (iii) all income, licenses, royalties, damages, profits, and payments relating to or payable under any of the foregoing; (iv) the right to sue for past, present, or future infringements of any of the foregoing; and (v) all other rights and benefits relating to any of the

foregoing throughout the world; in each case, whether now owned or hereafter acquired by Borrower ("Copyrights");

(b) All patents, patent applications, patent licenses (to the extent such licenses permit Borrower to grant a security interest), and patentable inventions of Borrower, including, without limitation, registrations, recordings, and applications thereof in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, including, without limitation, those set forth on Schedule A, and all of the inventions and improvements described and claimed therein; (ii) all continuations, divisions, renewals, extensions, modifications, substitutions, reexaminations, continuations-in-part, or reissues of any of the foregoing; (iii) all income, royalties, profits, damages, awards, and payments relating to or payable under any of the foregoing; (iv) the right to sue for past, present, and future infringements of any of the foregoing; and (v) all other rights and benefits relating to any of the foregoing throughout the world; in each case, whether now owned or hereafter acquired by Borrower ("Patents");

(c) All trademarks, trademark licenses (to the extent such licenses permit Borrower to grant a security interest), trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, logos, other business identifiers, all registrations, recordings, and applications thereof, including, without limitation, registrations, recordings, and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, including, without limitation, those set forth on Schedule A; (ii) all reissues, extensions, and renewals thereof; (iii) all income, royalties, damages, and payments now or hereafter relating to or payable under any of the foregoing, including, without limitation, damages or payments for past or future infringements of any of the foregoing; (iv) the right to sue for past, present, and future infringements of any of the foregoing; (v) all rights corresponding to any of the foregoing throughout the world; and (vi) all goodwill associated with and symbolized by any of the foregoing, in each case, whether now owned or hereafter acquired by Borrower ("Trademarks", and collectively with the Copyrights and the Patents, the "Intellectual Property");

(d) All books and records relating to any of the foregoing; and

(e) All proceeds, products and replacements of, accessions to, and substitutions for, any of the foregoing, including without limitation proceeds of insurance policies insuring any of the foregoing.

All of the property and interests in property described in subsections (a) through (e) are herein collectively referred to as the "Collateral."

This IP Security Agreement has been executed and delivered by Grantor for the purpose of registering the security interest of Lender in the Collateral with the United States Patent and Trademark Office and corresponding offices in other countries of the world. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to Lender under the Security Agreement. The Security Agreement (and all rights and remedies of Lender thereunder) shall remain in full force and effect in accordance with its terms.

**3. Representations and Warranties.** The Grantor represents and warrants to, and covenants with, the Lender, with respect to itself and the Collateral as to which it has or acquires any interest, that:

(a) To Borrower's knowledge, all of the registered Intellectual Property is subsisting, valid, and enforceable. The information contained on Schedule A hereto is true, correct, and complete. All issued patents, patent applications, registered trademarks, trademark applications, registered copyrights, and copyright applications of Borrower are identified on Schedule A hereto;

(b) Borrower is the sole and exclusive owner of the entire and unencumbered right, title, and interest in and to the registered Intellectual Property free and clear of any Liens other than Permitted Liens and rights of third parties granted by Borrower pursuant to licenses;

(c) To Borrower's knowledge, except as disclosed to Lender, no third party is infringing, or in Borrower's reasonable business judgment, may be infringing, any of Borrower's rights under the Intellectual Property;

(d) Borrower has performed and will continue to perform all acts and has paid and will continue to pay all required fees and Taxes to maintain each and every registered item of the Intellectual Property in full force and effect throughout the world, as applicable, except that Borrower is not obligated to pay any required fees and Taxes to maintain any registered item of the Intellectual Property that is no longer material to the business of Borrower;

(e) Except as identified on Schedule A, each of the Patents and Trademarks identified on Schedule A has been applied for and prosecuted consistent with the practice rules of the United States Patent and Trademark Office and the corresponding offices throughout the world identified on Schedule A and each of the Copyrights identified on Schedule A hereto has been applied for and prosecuted consistent with the practice rules of the United States Copyright Office and the corresponding offices throughout the world identified on Schedule A; and

(f) To Borrower's knowledge, no claims with respect to the Intellectual Property have been asserted and are pending (i) to the effect that the sale, licensing, pledge, or use of any of the products or services of Borrower's business infringes any other party's patent, copyright, trademark, service mark, trade secret, or other intellectual property right, (ii) against the use by Borrower of any Intellectual Property used in the Borrower's business as currently conducted, or (iii) challenging the ownership or use by Borrower of any of the Intellectual Property that Borrower purports to own or use, nor, to Borrower's knowledge, is there a valid basis for such a claim described herein.

The foregoing representations and warranties will be true and correct in all respects with respect to any additional Collateral or additional specific descriptions of certain Collateral delivered to Lender in the future by Borrower. The failure of any of these representations or warranties or any description of Collateral therein to be accurate or complete shall not impair the Security Interest in any such Collateral.

4. **Covenants.** So long as Lender is committed to extend credit to Borrower under the Credit Agreement and thereafter until the Obligations are paid and performed in full, Borrower covenants and agrees with Lender that Borrower will:

(a) Prosecute diligently all applications in respect of Intellectual Property, now or hereafter pending except that Borrower is not obligated to prosecute any application for Intellectual Property that is no longer material to the business of Borrower;

(b) Except to the extent not required or appropriate in Borrower's reasonable business judgment, make federal applications on all of its unpatented but patentable inventions and all of its registrable but unregistered Copyrights and Trademarks;

(c) Preserve and maintain all of its material rights in any material Intellectual Property and protect such Intellectual Property from infringement, unfair competition, cancellation, or dilution by all appropriate action necessary in Borrower's reasonable business judgment, including, without limitation, the commencement and prosecution of legal proceedings to recover damages for infringement and to defend and preserve its rights in the Intellectual Property;

(d) Not abandon any of the registered Intellectual Property necessary to the conduct of its business in the exercise of Borrower's reasonable business judgment;

(e) (i) Not sell or assign any of its interest in any of the Intellectual Property other than in the ordinary course of business for full and fair consideration without the prior written consent of Lender; (ii) not grant any license or sublicense with respect to any of the Intellectual Property other than in the ordinary course of business without the prior written consent of Lender; and (iii) maintain the quality of any and all products and services with respect to which the Intellectual Property is used;

(f) Not enter into any agreement, including, but not limited to any licensing agreement, that is or may be inconsistent with Borrower's obligations under this IP Security Agreement or any of the other Loan Documents;

(g) Give Lender prompt written notice, and in no event later than one (1) month, if Borrower receives any claim or demand with respect to the Intellectual Property (i) to the effect that the sale, licensing, pledge, or use of any of the products or services of Borrower's business infringes any other party's patent, copyright, trademark, service mark, trade secret, or other intellectual property right, (ii) against the use by Borrower of any Intellectual Property used in the Borrower's business as currently conducted, or (iii) challenging the ownership, registerability or use by Borrower of any of the Intellectual Property that Borrower purports to own or use.

(h) Give Lender written notice on a calendar quarterly basis if Borrower shall file an application for a patent, trademark or copyright, or obtain ownership of a patent, trademark or copyright or application therefore, not identified on Schedule A hereto; and

(i) If an Event of Default exists, use its reasonable efforts to obtain any consents, waivers, or agreements necessary to enable Lender to exercise its rights and remedies with respect to the Intellectual Property.

5. **Acknowledgment of Rights and Remedies.** Grantor does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

6. **Other Rights.** The rights, powers and remedies given to the Lender by this IP Security Agreement shall be in addition to all rights, powers and remedies given to the Lender under any other Loan Document or by virtue of any statute or rule of law. Any forbearance or failure or delay by the Lender in exercising any right, power or remedy hereunder shall not be deemed to be a waiver of such right, power or remedy, and any single or partial exercise of any right, power or remedy hereunder shall

not preclude the further exercise thereof; and every right, power and remedy of the Lender shall continue in full force and effect until such right, power or remedy is specifically waived in accordance with the terms of the Credit Agreement.




