THIS ASSIGNMENT OF TRADEMARKS (this "Trademark Assignment") is entered into as of August 26, 2005 (the "Effective Date") by and between ADDICO PRODUCTS, INC., a Nova Scotia corporation ("Assignor"), and ZOHAR WATERWORKS, LLC, an Delaware limited liability company ("Assignee"). This Trademark Assignment is being entered into pursuant to that certain Foreclosure Agreement dated as of August 26, 2005 by and between Assignor and Assignee (the "Foreclosure Agreement").

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of February 10, 2005 (as amended, restated or otherwise modified from time to time, the "Oasis Credit Agreement"), among Oasis, Sunroc LLC ("Sunroc" and, together with Oasis, the "Oasis Borrowers"), the guarantors party thereto (the "Oasis Guarantors"), the lenders party thereto (the "Oasis Lenders"), Wachovia Capital Finance Corporation (Central), as agent for the Oasis Lenders (in such capacity, the "Oasis Agent"), and Wachovia Capital Markets, LLC, as Sole Lead Arranger and Bookrunner, and certain other documents, instruments and agreements executed pursuant thereto or in connection therewith (collectively, the "Oasis Related Agreements" and together with the Oasis Credit Agreement, the "Oasis Credit Documents"), the Oasis Lenders have made loans to, and made other financial accommodations to or for the benefit of, the Oasis Borrowers (all such loans and other financial accommodations being herein referred to collectively as the "Oasis Loans"). The Oasis Loans and all other obligations of the Oasis Borrowers to the Oasis Lenders, howsoever created, arising or evidenced (collectively, the "Oasis Debt"), are secured by certain assets of the Oasis Borrowers and the Oasis Guarantors (collectively, the "Oasis Collateral"), including security interests in the Trademarks set forth on Schedule A attached hereto;

WHEREAS, the security interests in the Trademarks were perfected by the filing of a UCC-1 financing statement in the Secretary of State's Office for the State of Delaware, and Oasis Agent also filed notice of such liens in the United States Patent and Trademark Office (the "USPTO");

WHEREAS, as a result of continuing defaults by the Oasis Borrowers in the performance of the Oasis Debt, the Oasis Lenders have decided to sell and transfer to Waterworks, in a private sale, all of the Oasis Collateral in partial satisfaction of the Oasis Debt under Section 9-610 of the Ohio Uniform Commercial Code ("OHUCC"), Section 9-610 of the Delaware Uniform Commercial Code ("DEUCC") or the equivalent provisions of any relevant state's Uniform Commercial Code (together with the OHUCC and the DEUCC, the "UCC"), pursuant to that certain Foreclosure Agreement, dated as of the date hereof, among the Oasis Borrowers, the Oasis Guarantors, the Oasis Lenders, the Oasis Agent and the Assignee (the "Foreclosure Agreement");

WHEREAS, the Trademarks constitute part of the Oasis Collateral being sold or transferred by the Oasis Lenders to the Assignee, and, pursuant to the terms of the Oasis Credit Agreement and the Foreclosure Agreement, the Oasis Borrowers have the obligation to execute such documents as may be required to effectuate any sale of Oasis Collateral by the Oasis Lenders following an event of default under the Oasis Credit Agreement, and to assign, transfer or otherwise deliver record title to the Oasis Collateral to the Assignee;

EXECUTION COPY

WHEREAS, the Trademarks have been, or will be, sold, transferred and assigned by the Oasis Lenders to the Assignee pursuant to the terms of the Foreclosure Agreement, but the execution and delivery by Oasis of this Trademark Assignment for filing in the USPTO is required to transfer record title to the Trademarks from Oasis to the Assignee; and

WHEREAS, the Oasis Lenders are requiring Oasis, pursuant to the terms of the Credit Agreement and the Foreclosure Agreement, to execute and deliver this Trademark Assignment, for the purpose of evidencing such sale, transfer and assignment to the Assignee on the records of the USPTO pursuant to the Foreclosure Agreement.


FOR GOOD AND VALUABLE CONSIDERATION as recited in the Foreclosure Agreement, the receipt and sufficiency of which are hereby acknowledged, effective as of the Effective Date and as required by the Oasis Lenders pursuant to the Foreclosure Agreement, Oasis hereby transfers, assigns, conveys and delivers to Assignee, and its successors and assigns, all right, title, and interest that Assignor possesses and has the right to transfer in and to the registered trademarks and applications to register trademarks listed on Schedule A attached hereto (which is incorporated into and made a part of this Trademark Assignment), together with all of the goodwill associated with such trademarks and all rights to sue and recover for any past, present or future infringement, dilution, damage or injury (and including the right to take over and continue any and all existing suits) to any of the foregoing and collect profits or damages with respect to same, free and clear of all liens, claims, charges, security interests and other interests or encumbrances, the same to be held and enjoyed hereinafter by Assignee for its own use and for the use of its successors and assigns.

In the event of any conflict or inconsistency between the terms of this Trademark Assignment and the terms of the Foreclosure Agreement, the terms of the Foreclosure Agreement will prevail. Nothing contained herein shall be deemed to alter, modify, expand or diminish the terms of the Foreclosure Agreement.
