Please be advised that the undersigned entered into a Security Agreement dated as of October 1, 2002 (as amended, restated, modified, renewed, supplemented or extended from time to time, the "Security Agreement") by and among Avure Technologies, Inc., a Washington corporation, whose address is 23500 64th Ave South, Kent, Washington 98032 (the "Debtor"), Hydrodynamic Cutting Services, a general partnership, whose address 207 Nolan Road, Broussard, Louisiana, CIS Acquisition Corporation, a Michigan corporation, whose address is 601 Abbott Road, East Lansing, Michigan 48823 and Flow Waterjet Florida Corporation, a Florida corporation, whose address is 23500 64th Avenue South, Kent, Washington 98032 (collectively, the "Other Parties"), and John Hancock Life Insurance Company as Agent (the "Agent") for the lenders referenced therein (the "Lenders"), in which the Agent was granted a security interest in and continuing lien upon the trademarks and trademark applications listed in Schedule I attached hereto and incorporated by reference (collectively, the "Trademark Collateral"). The Security Agreement was recorded in the United States Patent and Trademarks Office on October 1, 2002.

Debtor acknowledges that Agent's release of all security interests in and all continuing liens upon the Trademark Collateral shall have no effect on any third party security interests in or continuing liens upon the Trademark Collateral.
