## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, made as of this 31 day of October, 2005 by and between, Adventist Hinsdale Hospital, an Illinois corporation ("Assignor") and Adventist Health System Sunbelt Healthcare Corporation, a Florida corporation ("Assignee");

WHEREAS, Assignor is the owner of and has adopted, used and is using the trademark listed in Schedule A attached hereto and made a part hereof, in various jurisdictions throughout the world (the "Mark"); and

WHEREAS, Assignee wishes to acquire the entire right, title and interest in and to the Mark in various jurisdictions throughout the world as listed in Schedule A and the goodwill connected with and symbolized by the said Mark; and

WHEREAS, Assignor wishes to assign the Mark and the goodwill connected with and symbolized by the said Mark;

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee the entire right, title and interest of Assignor in and to the Mark including the goodwill connected with and symbolized by the said Mark throughout the world and including the subject matter of all claims which may be obtained therefrom for Assignee's own use and enjoyment; together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.


Assignor authorizes and requests the respective local Registrars of Trademarks or other legal Trademark Authorities to record Assignee as the owner of the entire right, title and interest in and to the Mark, for the sole use and enjoyment of Assignee.

Assignor shall provide Assignee cooperation and assistance at Assignee's reasonable request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney or other documentation as may be reasonably required): (1) in the preparation and prosecution of any applications for registration of the Mark assigned herein; (2) in the prosecution or defense of any interference, opposition, cancellation, infringement or other proceedings that may arise in connection with any of the trademark rights assigned herein, including testifying as to any facts relating to this assignment or to the trademark rights assigned herein; (3) in obtaining any additional trademark protection in or to the Mark that Assignee may deem appropriate which may be secured under the laws now or hereafter in effect in the United States or any other country; and (4) in the implementation or perfection of this assignment.


