RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of October 31, 2005 (this "Release") is made by General Electric Capital Corporation, as agent for certain lenders ("Secured Party") under the Trademark Security Agreement dated as of April 29, 2004 as amended, restated, supplemented or otherwise modified prior to the date hereof, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 002838 Frame 0789, between The Tensar Corporation ("Debtor") and Secured Party (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtor's Trademark Collateral (as defined in the Security Agreement).

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademark Collateral; (ii) restore all right, title and interest in and to the Trademark Collateral to Debtor; and (iii) dissolve any and all liens and encumbrances respecting the Trademark Collateral under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademark Collateral, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Trademark Collateral under the Security Agreement.
