TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement"), effective as of November 4, 2005, (the "Effective Date"), is made by and between Application Systems Technology, Inc., a Kansas corporation, R-Con Corporation, a Kansas corporation, Hesston Ready Mix, Inc., a Kansas corporation, Ark River Sand of Oklahoma, Inc., a Kansas corporation and Ark River Sand, Inc., a Kansas corporation (each individually an "Assignor" and collectively the "Assignors"), and Lafarge North America Inc., a Maryland corporation ("Assignee").

W I T N E S S E T H:

WHEREAS, the Assignors and Assignee are parties to that certain Asset Purchase Agreement entered into on September 22, 2005 (the "APA"), under which portions of the Assignors' businesses were transferred to Assignee;

WHEREAS, the Assignors have individually adopted, used and in some instances have registered or applied to register a number of trademarks, service marks, logos, trade names and business names in association with the portions of the Assignors' businesses that were transferred to Assignee in the APA, including, but not limited to those trademarks, service marks, logos, trade names and business names and all variations thereof set forth on the attached Exhibit A (the "Marks");

WHEREAS, the Assignors have agreed to assign and Assignee has agreed to acquire all of the Assignors' rights, title, and interests in and to the Marks, both registered and common law, the goodwill of the businesses symbolized thereby, and the right to recover damages and profits for past infringement thereof; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Each individual Assignor hereby assigns, transfers and conveys unto Assignee, all of its rights, title and interests in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.
2. Pursuant to the APA, the Assignors have assigned, transferred and conveyed unto Assignee, all of the Assignors' individual rights, title and interests in and to the portions of the businesses of Assignors to which the Marks pertain.
