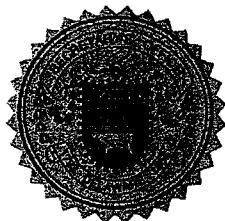

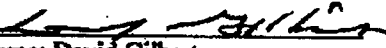

Section 251 of the General Corporation Law of the State of Delaware

The undersigned, an officer of ERisk Holdings, Inc., a corporation organized and existing under the laws of the State of Delaware, DOES HEREBY CERTIFY:

1. That the name and state of incorporation of the constituent corporations are as follows:
 - (a) ERisk Holdings, Inc., a Delaware corporation ("ERisk"); and
 - (b) Risk Analysis Inc., a Delaware corporation ("Merger Sub").
2. That a Merger Agreement, dated as of November 8, 2005 (the "Merger Agreement"), by and among SunGard Data Systems, Inc., a Delaware corporation ("Parent"), Merger Sub, a Delaware corporation and an indirect wholly owned subsidiary of Parent, ERisk and the principal stockholders of ERisk signatory thereto, pursuant to which Merger Sub will merge with and into ERisk (the "Merger") so that the separate existence of Merger Sub will cease as soon as the Merger becomes effective, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Sections 251 and 228 of the General Corporation Law of the State of Delaware.
3. The surviving corporation shall be ERisk.
4. That the Certificate of Incorporation of ERisk, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the Surviving Corporation, except that Article 1 of the Certificate of Incorporation is hereby amended to change the name of ERisk to SunGard ERisk Inc.
5. That the executed Merger Agreement is on file at the principal place of business of the Surviving Corporation: 1500 Broadway, 18th Floor, New York, New York 10036.
6. That a copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.
