WORLDWIDE ASSIGNMENT OF TRADEMARK

In consideration of SAH's agreement to grant a worldwide exclusive license to Shure and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Shure has assigned and hereby assigns, transfers, conveys and sets over to SAH, the entire right, title and interest in to the Trademark including title to all registrations issuing from all applications therefore, worldwide, along with the worldwide goodwill of the business connected with the Trademark, the same to be held and enjoyed by SAH, its successors, assigns and other legal representatives. Shure further assigns to SAH worldwide all right to sue for and collect all damages accruing from past, present and future infringement of the Trademark.

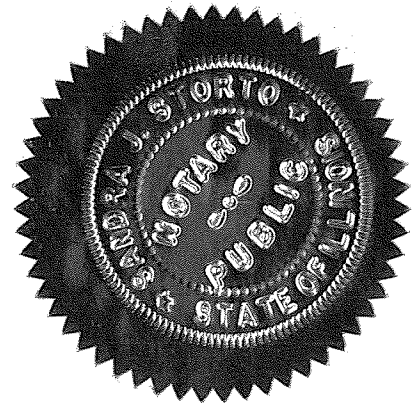
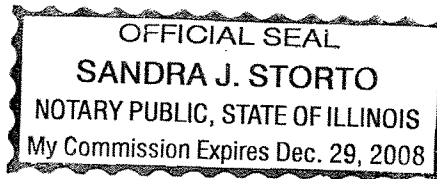
