**RELEASE OF SECURITY INTEREST**

WHEREAS, by a certain Collateral Assignment of Trademarks and Tradenames dated as of April 13, 2000 (the "Collateral Assignment") between Frederick Goldman, Inc. (as defined in the Collateral Assignment as "Assignor"), and Fleet Precious Metal Inc., as Agent for itself and Agent for Fleet National Bank, Sovereign Bank, HSBC Bank USA, The Chase Manhattan Bank and ABN Amro Bank N.V. New York Branch (together with any successor(s) thereto in such capacity - as defined in the Collateral Assignment) (collectively the "Lenders"), Assignor granted to the Lenders a security interest in and lien on certain trademarks and tradenames as defined in said Collateral Assignment as the "Marks"; and certain trademarks licensed to Assignor as defined in said Collateral Assignment as the "Licensed Marks";

WHEREAS, the Collateral Assignment was recorded with the Trademark Division of the U.S. Patent and Trademark Office on May 11, 2000 at Reel/Frame 2066/0501 and on June 26, 2001 at Reel/Frame 2318/0862;

WHEREAS, the Collateral Assignment was reaffirmed and amended by Assignor and Agent on behalf of the Lenders by a certain Reaffirmation of and Second Amendment to Collateral Assignment of Trademarks and Tradenames as of June 10, 2003 (the "Reaffirmation"); and

WHEREAS, the Reaffirmation was recorded with the Trademark Division of the U.S. Patent and Trademark Office on July 7, 2003 at Reel/Frame 2775/0944 and on July 27, 2005 at Reel/Frame 3166/0874.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Lenders, does hereby fully release and discharge its security interest in and lien on the Marks and Licensed Marks, including, without limitation, the trademarks and tradenames listed in Schedule A and Schedule B hereto, the debt secured thereby having been paid and satisfied in full, and assigns to the Assignor any and all right, title and interest in and to the Marks and Licensed Marks and the goodwill associated therewith that it may have.
