THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated October 20, 2005 by Columbus Nova Partners LLC, as hereinafter described;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged;



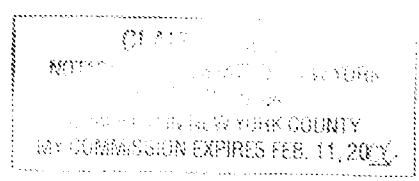
