RELEASE AND REASSIGNMENT OF TRADEMARK

THIS RELEASE AND REASSIGNMENT OF TRADEMARK dated August 17, 2005 by Sand Hill Capital II, L.P., as hereinafter described;

WITNESSETH:

(b) All proceeds of the foregoing, including without limitation any claim by Assignor against third parties for damages by reason of past, present or future infringement of the Trademark listed on Schedule A hereto or by reason of injury to the goodwill associated with such Trademark, in each case together with the right to sue for and collect said damages.

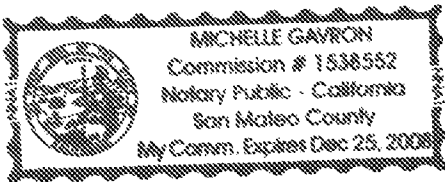

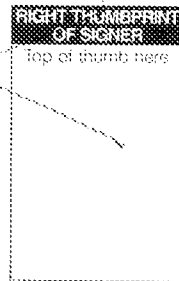
