**TERMINATION OF SECURITY INTEREST  
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of October 31, 2005, is made by GENERAL ELECTRIC CAPITAL CORPORATION, as Agent for Lenders (the "Agent").

WHEREAS, PROFESSIONAL SERVICE INDUSTRIES, INC. (the "Grantor") has granted to the Agent, for itself and the Lenders, a security interest in certain personal property, including without limitation a security interest in certain trademarks, trademark registrations and trademark applications ("Trademarks") and trademark licenses ("Trademark License");

WHEREAS, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office on September 25, 2002 at Reel 002589 and Frame 0424; and

WHEREAS, in connection with the payment in full of all obligations of the Grantor to the Agent as described in the Payoff Letter dated October 31, 2005 between Grantor and the Agent, the Agent has agreed to terminate and release its security interest in all of such Trademarks and Trademark Licenses, including, without limitation, Trademarks and Trademark Licenses identified on Schedule I hereto, as herein provided;


NOW, THEREFORE, for valuable consideration, the Agent hereby terminates and releases all mortgages, liens and security interests granted to the Agent in the following Trademarks and Trademark Licenses:

1. all of the Grantor's Trademarks and Trademark Licenses to which the Grantor is a party including those referred to on Schedule I hereto;
2. all reissues, continuations or extensions of the foregoing;
3. all good will of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
4. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.
