CERTIFICATE OF OWNERSHIP AND MERGER

Vaisala Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 29th day of May, 1981, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the stock of Vaisala Meteorological Systems Inc., a corporation incorporated on the 21st day of May, 2001 pursuant to the General Corporation Law of the State of Delaware.

RESOLVED: That the President and Secretary of the Corporation be and each hereby is, authorized to execute a Certificate of Ownership and Merger with respect to the merger of Vaisala Meteorological Systems Inc. into the Corporation, cause the same to be filed with the Secretary of State of Delaware and take all such other actions and to execute all such other instruments and agreements as they or any of them may deem appropriate to effect such merger;
