TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Agreement") is made and entered into as of September 30, 2005, by OLD WORLD INDUSTRIES, INC., an Illinois corporation ("Grantor"), in favor of GMAC COMMERCIAL FINANCE LLC, in its capacity as administrative agent for Lenders (the "Administrative Agent").

W I T N E S S E T H:

WHEREAS, pursuant to that certain Term Loan Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Term Loan Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Term Loan Agreement), by and among Old World Industries I, Ltd. ("Borrower"), Grantor, the other Loan Parties from time to time signatory thereto, the Administrative Agent and the other Agents and Lenders from time to time signatory thereto, the Lenders have agreed to make Term Loans to Borrower; and

WHEREAS, Administrative Agent and the other Agents and Lenders are willing to make the Term Loans as provided for in the Term Loan Agreement, but only upon the condition, among others, that Grantor shall have executed and delivered to the Administrative Agent, for itself and the benefit of Lenders, the Security Agreement; and

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver this Agreement to the Administrative Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, Grantor hereby agrees with the Administrative Agent as follows:

1. Grant of Security Interest in Trademark Collateral. To secure the prompt and complete repayment and performance of Grantor's Obligations under the Term Loan Agreement and other Loan Documents, Grantor hereby grants to the Administrative Agent, for itself and the benefit of Lenders, a continuing first priority security interest in and lien upon (subject to Permitted Liens and except as set forth in the LaSalle Intercreditor Agreement) all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"): (a) all of its trademarks and trademark licenses to which it is a party including, without limitation, those set forth on Exhibit A attached hereto; (b) all reissues, continuations or extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark license; and (d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future: (i) infringement or dilution of any trademark or trademark licensed under any trademark license, and (ii) injury to the goodwill associated with any trademark or any trademark licensed under any trademark license.

2. Pledge and Security Agreement. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Administrative Agent, for itself and the benefit of Lenders, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement and the LaSalle Intercreditor Agreement, the terms and provisions of which are incorporated by reference herein as if set forth at length herein.

3. Counterparts. This Agreement may be executed in multiple counterparts (any of which may be delivered by facsimile), each of which shall constitute an original and all of which taken together shall constitute one and the same Agreement.

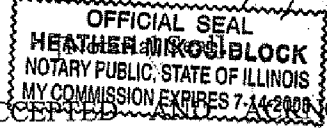
