

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
HR-IC, L.L.C**

**Originally Filed as LPA-IC Construct Engineering, L.L.C. on May 16, 2000
Amended to HR-IC, L.L.C. on January 28, 2004**

Pursuant to provisions of Title 29, Chapter 10 of the Code of Laws of the District of Columbia, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is HR-IC, L.L.C.

SECOND: The following amendments to the Articles of Organization were duly adopted on behalf of the company on October 18, 2005, in accordance with the Operating Agreement and all applicable laws of the District of Columbia.

In Article First, the name of the company is changed to Health Care Policy Roundtable, L.L.C.


THIRD: The effective date of this amendment shall be the date of delivery for filing with the Corporations Division


FOURTH: The amendment received was approved by those members with voting rights holding at least a majority of the interest in profits of the limited liability company.
